PREFACE

Through this research project a dated copy of the 1961 Geary County, Kansas Directory of Social Resources was located and the need for a new directory was determined by the writer. Most of the representatives of organizations and agencies with whom the author conversed expressed their lack of knowledge about the kinds of resources available in the community. Also, they verbalized a real need for the kind of information included in the new directory for 1973.

The writer wishes to express her gratitude to those organizations, agencies, and individuals who contributed to the success of this project. Thanks also, to Dr. Marjorie Stith, head of the Department of Family and Child Development for her counseling and supervision. A special word of appreciation for the expert advice and guidance of those who served on her graduate committee: major professor, John Selfridge, and committee chairman, professor Ray Weisenberger (both of whom are in the Department of Regional and Community Planning); and Dr. Carol Kennedy of the Department of Family and Child Development. Gratefulness is also expressed for the advice, encouragement, and prodding of her husband, Rev. Alvin Lewis, who had faith in her even when the task seemed almost overwhelming.

Chapter 1

INTRODUCTION AND PROBLEM STATEMENT

During the first week of January 1973 I arranged separate appointments with two commissioners, the City Manager, and the executive officer at the Health Department; all of whom were local officials of Junction City. I talked with them about the probability of the city financing a public training program for persons involved in or interested in the care and instructing of children under twelve (12) years of age. Such a training program for adults could include information about various social resources available to families and children along with the direct material related to the care and training of children. One or two of the officials did not think it would be easy to secure information about the social resources available to the people of Geary County. They vaguely recalled that a social service directory had been printed some years ago, but neither of the officials had a copy of that out-dated directory or knew where a copy could be acquired.

A few weeks later, the Spring semester at Kansas State University began, and I was enrolled in a "Practicum in Community Services" in the Department of Family and Child Development. Dr. Marjorie Stith, the department head, and I discussed several possible projects of interest to me; one of these was the forming of a "4-C" committee (Coordinating Council of Community Services to Children) in Junction City or the Geary County area. Such a project would have necessitated contacting various community organizations or agencies interested in the well-being of

children to serve on the council. It was thought that I could have been responsible for getting the names and addresses of persons to be contacted for a multi-county conference where the "4-C" program would be explained. Whatever social emphasis I approached, in an effort to hopefully enhance services to children, the need for a listing of agencies and organizations became apparent.

Dr. Stith and I then discussed the matter of a social service directory at length. We finally decided that it would be advantageous to find out whether an up-dated directory could be secured which gave information about the Junction City/Geary County agencies and/or organizations.

My search for a directory led me to make many inquiries at public agencies, as well as, among private citizens. One of my first more fruitful inquiries was at the Junction City Chamber of Commerce. Mr. Dan Loeb, the Executive Director, gave me a copy of the Junction City-Geary County, Kansas Factual Data published by the Economic Development Commission in Junction City. He also provided me with copies of the lists of Civic, Fraternal, and Veteran organizations printed annually by the Chamber of Commerce. Mr. Loeb could not, however, give me any information about a previously compiled social service directory for this community. He suggested that I contact the library for the material I was seeking. Neither the George Smith Public Library nor the Junction City Union Newspaper office had any kind of listing of social service agencies and organizations other than that provided by the Chamber of Commerce. In fact, they suggested that

I might get the information I wanted from the Chamber of Commerce, the Geary County Courthouse, or the Municipal Office. I further explained that the detailed material about the services offered by the community organizations could not be found earlier at the Chamber of Commerce, but I would continue my search. I mentioned that this was one of my projects at the University and that it might become necessary for me to actually gather and compile material which would be found in a social service directory. Each agency representative expressed that such information could be helpful to them when making referrals, so they hoped that whatever directory resulted from my research could be made available.

Progress on locating a social service directory was nil up to this point, however, I had accomplished something; I knew some of the places where the social resource directory (if one existed) had not been distributed. I was ready to conjecture that if such a directory had been in existence it was not still in circulation.

Later I learned through my husband, that a local pastor and friend, Reverend Earl Holmes, had done some research on social service resources in Junction City about six years ago while attending Manhattan Bible College. In conversation with Rev. Holmes, he explained that he had been unable to locate the list of resources he compiled, nevertheless, he did have a copy of the 1965 Junction City Directory which also included Geary County Taxpayers. I borrowed the Directory only to discover that it was much too complicated to be useful to my project. It listed all

businesses, people, addresses, locations, facilities, advertisements, etc. in the area. Also, the information provided was at least seven (7) years old.

After discovering that I was unable to use the 1965 Junction City Directory and that Dr. Stith could not get any useful information from it, I asked Mr. Loeb to further assist me. Seeing too, at that time, that the Chamber of Commerce had several more recent copies of the Directory, I felt sure Mr. Loeb could help me in extracting the social information I desired. Mr. Loeb did not hesitate to admit that he did not understand clearly the use of the directory nor did he try to follow the involved instructions. In other words, the City Directory was subscribed to by the Chamber of Commerce to be available to persons who desired to use it.

Eventually, I went to the Geary County Courthouse where I was given a list of the Geary County Officials for 1973 through 1975. Afterward, I visited the Junction City Office in the Municipal building in hopes of finding a service directory of some type, but the receptionist could only tell me who the city officials were (for they did not have any printed lists to hand out). Initially, the receptionist was reluctant to give any information to me and even when giving the names of the officials she kept expressing her uneasiness about it. Despite the fact, that I kept trying to explain who I was and why I was making the inquiry, the receptionist was still leery of me as I left the building.

It was during my call at the U. S. O. that I began to believe that the search for a directory was not all in vain. It was there that I received a copy of the Fort Riley, Army Community Services Directory, as well as, other materials about other public facilities providing services for the military personnel and their families. Brigadier and Mrs. Harold Wright, the U. S. O. director and his wife, also offered to secure additional information pertaining to civilian and military services in the community. Before the termination of that visit Mrs. Wright mentioned that I might be interested in seeing a copy of the last Geary County Directory of Social Resources which Brig. Wright had at home. She said I could pick it up later at the U. S. O. Mrs. Wright also thought that the Chamber of Commerce should have information concerning clubs and associations which did not appear on the lists I had received.

I decided to make another visit to the Junction City Chamber of Commerce hoping that Mr. Loeb could provide additional information pertaining to clubs or associations which did not appear on their published lists of organizations. It was then that I was allowed to copy information from the hanging card file which Mr. Loeb and his staff maintains for office use in making referrals. Information for the file is secured from newspaper reports and from some organizations who notify the Chamber of Commerce directly of changes. According to Mr. Loeb most civic, fraternal, veteran, Greek organizations, clubs, and associations hold annual elections. The new officials usually assume their positions at the beginning of their calendar year (either the first of January or the first of July).

Two weeks later I picked up the dated copy of the Geary County, Kansas Directory of Social Resources at the U. S. O. The Directory had been published by the Council of Social Agencies (Geary County, Kansas) May 1, 1961. In its' preface special mention is made of the fact that the information contained therein was about the community groups who were members of the council. In the future they had hoped to enlarge the Directory by including information about other groups rendering social services.

Prior to getting the copy of the dated Geary County Directory I had drawn up a questionnaire to be sent to all agencies and organizations providing social services to Geary County/Junction City area. (See copy of questionnaire in Chapter 2.) I was amazed to see that the material included in the dated directory was similar to much of that requested through my questionnaire.

METHODOLOGY

1. Through the contacts discussed in the introduction of this report along with the inclusion of 31 churches as social agencies I made a list consisting of 130 possible social resources in Geary County.
2. Inquiries about a possible existing directory led to the locating of a dated directory for Geary County, Kansas.
3. The comparing of the dated directory with the compiled list of organizations and agencies revealed that only 12 of them were included on both. So 17 of the 130 possible agencies were taken from the dated directory.
4. A three page questionnaire was drawn up and reproduced prior to the locating of the dated directory. The questionnaire contained 17 different questions.
5. Copies of the questionnaire were mailed along with a cover letter and a self-addressed stamped envelope to a total

- of 94 agencies/organizations. (Churches and township trustees were not sent questionnaires.)
6. A master list of all organizations/agencies included in this study was made so that data could be easily kept.
 7. Most agencies/organizations that were slow in responding to the questionnaire were contacted by telephone.
 8. Eight duplicate questionnaires had to be sent along with self-addressed stamped envelopes to those agencies that lost the first copy.
 9. A plan for keeping the directory up to date is being arranged.
 - a. The Chamber of Commerce is accepting the responsibility for printing up-dated lists of the heads of organizations who hold annual elections. These lists can be sent to any Directory purchaser who desires to receive them.
 - b. Plans are being made through the Metropolitan Planning Commission for the Directory to be up-dated every three years. This will necessitate the printing of a supplement showing the Directory changes, corrections, and additions. The supplements will be sent to Directory purchasers free of charge.
 10. The price to be charged for the new directory will be decided after the cost of printing it is known.

11. The information to be used in the Junction City/Geary County new Resource Directory has been provided by the agencies and organizations through the questionnaire used in this study.

Chapter 2

THE SURVEY

Geary County, Kansas did not have an up-to-date directory of human services, so the responsibility of compiling and organizing a completely new directory was assumed by the author. The organizations and agencies that supplied the necessary information through the questionnaire survey have been included in the new directory.

The survey materials used were:

Resource Lists: A master list was compiled and a coding system developed to keep an accurate record showing all organizations/agencies sent questionnaires; those responding or not responding to the questionnaires; those to whom follow up contacts were made; and those on the initial list who had also been listed in the dated directory.

Cover Letters: A copy of the cover letter accompanied each questionnaire mailed out.

Questionnaires: A three page questionnaire consisting of 17 questions was sent to each organization/agency whose detailed material is part of section 2 in the new directory.

Samples of the materials used are contained within this survey section.

Using the informational codes of the master list the following tables were constructed:

Table 1. List of the organizations and agencies from whom information was received through the questionnaires.

Table 2. A list of those agencies and organizations whose responses, as of July 25, 1973, had not been received.

Table 3. This table summarizes the research done through the use of the questionnaire.

Chapter 3

EVALUATIONS

EVALUATION OF THE QUESTIONNAIRE

The questionnaire used in this study of social resources in Junction City/Geary County area was a successful method of securing information from agencies and organizations. Yet there could be some criticism of the questionnaire's organization of inquiries.

1. The first page of the questionnaire was drawn up with the purpose of contacting responding agencies and organizations afterward to arrange interviews to get more detailed information. However, the lists of agencies, organizations, and individuals to be contacted about community services became more and more extensive, so, my supervisor and I thought it best to make some additions to the questionnaire. This accounts for some of the slight appearance of disorganization in the questionnaire. There are questions on page 2 and 3 that relate to or could have been attached to questions on page 1.

For example: The name of the organization responding is on page 1, but the organization's abbreviations are not requested until page 2.

Secondly, the kinds of services rendered are listed on page 1 of a respondent's questionnaire, but charges for services are not stated until the bottom of page 2. Furthermore, the

eligibility requirements are not even indicated until page 3 where the free services provided are also listed.

2. A few unessential questions were asked which could have been eliminated for this study. One of these concerned the use of funds. Most organizations were reluctant to answer the question; and agencies found it easy to either give the percentage of funds used for general categories or just state the name of the agents determining the budget. The reason for the question was not clear.

3. The request for a brief history of the local agency or organization was evidently confusing to many organizations. Less than seven respondents provided the information requested. Others gave the history of the national organization with which they are connected.

4. Even though some related questions are separated I believe this is a good questionnaire. A questionnaire which separates related or connecting information has its advantages. It allows the person providing the answers to add pertinent facts which he might not have given in his first answer to the question. Related questions expand the thoughts about a particular thing but do not necessarily have to be placed together. The kinds of services and the cost of services are related, nevertheless, one elaborates on the function while the other is concerned with finance. Therefore, the financial questions have been placed in successive order on page 2. To avoid confusion the question regarding free services appears at the top of

page 3. This question when answered not only clarified what services are free but often revealed services not listed under kinds of services for question four on page 1.

IMPLICATIONS AND RECOMMENDATIONS

Anyone desiring to undertake a similar study for another area would find it advantageous to inquire at the Chamber of Commerce and other active public agencies about the names of organizations and agencies. The researcher should arrange a file system for keeping track of questionnaires and the information gathered. In the research on Junction City/Geary County resources each resource named was given its own number on the master list, so, the same number was assigned to the questionnaire before it was mailed to that organization or agency.

The researcher in the quest for social information discovered the value of establishing good relationships with the community representatives. And the lines of communication should be kept open because each source is believed to be important to someone and it might be called on to serve a particular future need.

The individual desiring to embark on such a project should have a fairly clear idea of the kind of information which will be of value to the general public. For, the researcher's convictions about human resources or human services will influence greatly the type of directory produced.

Even though in the Junction City/Geary County project the source, problem, and plan was not publicized through the available communication media; the author strongly recommends that the community first be made aware of such a project through the public media. It is believed that the public announcements will enhance the chances of getting total cooperation from the organizations and agencies serving the area.

The Directory will be available to all organizations, agencies, and individuals to provide them with ready information about the functions of various resources in the community. Hopefully, it will help to avoid some of the confusions about services and eligibility requirements of these organizations or agencies. Also, this Directory will enable its users to refer persons directly to the proper sources which can best answer their inquiries.

I believe this Directory of Community Resources will be useful to all citizens of Geary County, however, it will be especially beneficial to those in professions to have ready access to this Guide (Educators, Attorneys, Social Workers, Ministers, Counselors, Secretaries, Doctors, Nurses, Extension Agents, Home Economists, Administrators, Librarians, etc.).

Every effort has been made to include all organizations and agencies rendering any kind of social service to the community. Any omission of an organization is not intentional and is not meant to imply that an unmentioned organization is not providing a community service.

The plan is to up-date the Geary County Community Resources Directory every three years. However, organizations who change leaders each year are asked to notify the Junction City Chamber of Commerce of the new leader's name, mailing address, and telephone number. Copies of these amendments will be available to the public at the Chamber of Commerce, Fifth and Washington Streets, Junction City, Kansas. Otherwise, the tri-annual updating will be done through the Metropolitan Planning Commission in Junction City, Kansas. It is hoped that the Commission can secure information on all additions or corrections to be made in the Directory.
