- Prepare an half-yearly report describing the successful implementation of UMHMF KPHA Breastfeeding Grant in 23 counties of Kansas
- Interact with representatives from grantee counties and officials from State Health department
- Organize a workshop and a breakout session at KPHA Annual Fall Conference 2012

UMHMF KPHA Breastfeeding Grant

□ Purpose, Background, and Scope

- Support improvements in breastfeeding duration and initiation rates in targeted communities
- Grant of \$10,000 by UMHMF to each eligible county for a period of one year (2012)
- Eligible Applicants
 - County Public Health Departments of 23 counties
 - Collaborations encouraged
 - Counties with successful implementation of grant in 2011
- Reporting Requirements
 - Quarterly report by grantees to KPHA
 - Half-yearly report by KPHA to UMHMF
- □ Continuation of funding in future
 - 30 counties given grant during 2 years
 - Collaboration with KDHE to develop new breastfeeding projects

Interaction with County Health Departments and State Health Department Officials

- □ Mode of Communication : Skype and email
- Weekly Audio/Video Skype sessions with Elaine Schwartz
- Email blasts: communication with county health departments and State Health Department officials
 - Uniformity of information
 - Reach out large number of officials simultaneously
